

MEMORANDUM OF AGREEMENT BETWEEN FACULTY OF LAW UNIVERSITAS MALIKUSSALEH

# INTERNATIONAL CENTRE FOR ACEH AND INDIAN OCEAN STUDIES (ICAIOS) CONCERNING THE COOPERATION OF TRI DHARMA OF HIGHER EDUCATION

Today is Wednesday, the twenty six of June in the Year Two Thousand Twenty-Four (26-06-2024) at Law Faculty Universitas Syiah Kuala Banda Aceh and the International Centre for Aceh and Indian Ocean Studies (ICAIOS), we are the undersigned:

1.	Dr. Faisal, S.Ag, S.H., M.Hum.	:	In his position as Dean of the Faculty of Law Universitas Malikussaleh, in this case, acting for and on behalf of the <b>Faculty of Law USK</b> , which is domiciled at Jalan Jawa No. 1 Kampus Bukit Indah Blang Pulo, Lhokseumawe 24351, Aceh Province, hereinafter referred to as the <b>FIRST PARTY</b> .
2.	Reza Idria, S.H.I., M.A., Ph.D	:	In his position as Director of the International Centre for Aceh and Indian Ocean Studies (ICAIOS), in the International Centre for Aceh and Indian Ocean Studies (ICAIOS), which is domiciled at Jalan. T. Nyak Arief, Darussalam, Banda Aceh hereinafter referred to as the SECOND PARTY.

The **FIRST PARTY** and the **SECOND PARTY** are collectively called the **PARTIES**, and individually referred to as the **PARTY**. THE **PARTIES** first explain that:

- a. The **FIRST PARTY** is a State Higher Education Institution located on Jalan Jawa No. 1 Kampus Bukit Indah Blang Pulo, Lhokseumawe, which carries out the mandate, duties, and functions of the Tri Dharma of Higher Education in the fields of education, research, and community services.
- b. The SECOND PARTY is an International Centre for Aceh and Indian Ocean Studies (ICAIOS) located at Jalan. T. Nyak Arief, Darussalam, Banda Aceh City.
- c. The **PARTIES** have resources of potential and capabilities that, if combined and used, can enhance performance and generate more advantages for both **PARTIES**.
- d. To utilize these resources and potentials optimally, it is necessary to have synergy between the **PARTIES**.

Based on the above considerations, and in good faith, and still guided by the provisions of laws and regulations, the **PARTIES** hereby agree to cooperate in the development of human resources, the development of science and technology, and innovation with the following terms and conditions.

### PURPOSE

This Memorandum of Agreement aims to establish a cooperative relationship that is beneficial for the interests of the **PARTIES** in accordance with their respective duties, functions, and capacities by utilizing the resources owned by the **PARTIES**.

#### SCOPE

The cooperation between **PARTIES** includes matters related to the Tri Dharma of Higher Education, especially in the field of development of science, technology, and innovation, but not limited to the development of human resources, in the form of:

- a. Research Collaboration and Community Service
- b. Education and Research training
- c. Scientific meetings (seminars, workshops, conferences) both nationally and internationally;

### MONITORING AND EVALUATION

- 1. **PARTIES** must conduct monitoring and evaluation either individually or together at least once a year.
- 2. The results of this monitoring and evaluation will be used as consideration in conducting cooperation in the future.
- 3. Utilization of laboratory scientific tools, as well as scientific information facilities; Development of innovation;
- 4. Other activities agreed by the **PARTIES**, which are in accordance with the objectives of the Memorandum of Agreement

### BUDGET

- 1. The funds required for the implementation of this Memorandum of Agreement shall come from the PARTIES' respective budgets as well as from other acceptable sources that comply with applicable laws and regulations.
- 2. The budget as mentioned in paragraph (1) shall be further regulated by the **PARTIES** to the Cooperation Agreement as mentioned in Article 3, which is an integral part of this Memorandum of Agreement.

### PERIOD

- 1. This Memorandum of Agreement is valid for 5 (five) years, starting from the moment it is signed, and can be extended in accordance with the agreement of the **PARTIES**
- 2. If this Memorandum of Agreement is to be terminated by one **PARTY**, the **PARTY** who will terminate this Memorandum of Agreement must notify the other **PARTY** in writing within 1 (one) month before this Memorandum of Agreement is terminated.

# DISPUTE SETTLEMENT

Any dispute arising from the interpretation or implementation of this Memorandum of Agreement may be resolved amicably through consultation and negotiation by the **PARTIES** in the spirit of cooperation.
